Business Challenges

The company acquired a pensions division from one of the leading providers in the region and the challenge was migrating all the business onto their own systems and managing all the changes in business processes and work flows. The plan was to complete this transition onto the incumbent platform, SimCorp Dimension, in five months.

The transition of the business and all the relevant data was complex and involved many areas including change of custodian, collateral management, derivatives clearing, clearing brokers, FX services, trade confirmation, clearing and settlement, etd clearing, legal documentation and reporting such as Solvency II and FSA reporting

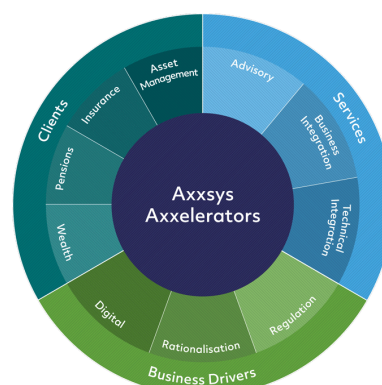
